REORGANIZATION MEETING

6:00 p.m., January 4th, 2010

A special meeting of the Paxtang Borough Council was called to order at 6:00 p.m., on January 4th, 2010 by Councilman John R. Ninosky, Sr.. Mayor Keldeen Stambaugh being absent due to a planned personal trip, Mr. Ninosky inquired with those members of Council present if anyone had an objection to his presiding over the meeting until such time as the election for President of Council and Vice-President could be conducted. Hearing no objection, Mr Ninosky proceeded with the Order of Business, stating that this meeting was being held for the purpose of electing a Council President and Vice-President, to appoint various other officers for the Borough, and any other business to be brought before Council.

Mr. Ninosky led the Pledge of Allegiance to the Flag.

Magisterial District Judge Michael J. Smith administered the oath of office to the following persons duly elected to the office of Council.

The Council Members took their positions at the council table.

Judge Smith administered the oath of office to Helen J. Koser, duly elected to the office of Tax Collector for a term of 4 years

Judge Smith administered the oath of office to Devon Alleman, duly elected to the office of Auditor for a term of 6 years

Mr. Ninosky called for nominations for the office of Council President.

*1) Councilman Beaver nominated John Ninosky for the Office of President. Motion seconded by Councilwoman Panza. There being no further nominations, Mr. Ninosky stated that the nominations for Council President were closed and directed the Secretary to call for the vote as follows:

Mr. Ninosky directed the Secretary to cast a unanimous ballot and declared Councilman John Ninosky elected to the office of President of Council.

President Ninosky called for a motion to appoint the Non-Uniform Pension Trustees. Manager Beard mentioned that previously the appointees have been the President and Vice-President of Council.

*5) Councilwoman Panza made a motion to appoint President Ninosky and Vice-President Beaver. Motion seconded by Councilwoman Borne-Fuller. Motion carried.

President Ninosky called for a motion to reappoint Leon Feinerman as Broker of Record for 2010.

*6) Councilman Borne-Fuller made a motion to reappoint Leon Feinerman as Broker of Record for 2010. Motion seconded by Councilwoman Panza. Motion carried.

President Ninosky called for a motion to authorize the Secretary/Treasurer to pay bills for labor, contracted items and discount bearing accounts.

*7) Councilwoman Panza made a motion to authorize the Secretary/Treasurer to pay bills for labor, contracted items and discount bearing accounts. Motion seconded by Councilwoman Borne-Fuller. Motion carried.

President Ninosky called for a motion to approve the Rules of Council for 2010 through 2012.

*8) Councilwoman Panza made a motion to adopt the Rules of Council for 2010 through 2012. Motion seconded by Councilwoman Borne-Fuller. Motion carried.

Consideration of Resolution 1-10, Naming Metro Bank as Depository: Manager Beard advised Council that paragraph one should read January 4, 2010 and on page two the last paragraph should also read January 4, 2010. Manager Beard will ensure that these changes will be made in the Resolution to be signed and recorded.

*9) Vice-President Beaver made a motion to approve **Resolution 1-10** with the change of date. Motion seconded by Councilwoman Panza. Motion carried.

Manager Beard asked Council to consider a request from Murvin E. Grunden, Captain of the Fire Police, to approve the use of Fire Police Officers at certain non-emergency functions during the 2010 year.

*10) Councilwoman Borne-Fuller made a motion to approve the use of Fire Police at the non-emergency functions listed in the request, as well as any additional events that may arise and are deemed necessary by the Chief of Police or his designated Officer-In-Charge, motion seconded by Councilwoman Panza, motion carried.

Manager Beard read a second memo from Captain Grunden identifying those individuals who have been selected as Fire Police Officers for 2010 and asked Council to recognize them as such. President Ninosky acknowledged the memo on behalf of Council.

President Ninosky called for a motion to appoint Secretary Clark to serve as the Acting Borough Manager for the period of January 11 through January 22nd, 2010, due to the anticipated absence of Manager Beard. *11) Vice-President Beaver made the motion, seconded by Councilwoman Borne-Fuller. Motion carried.

President Ninosky adjourned the Reorganization meeting at 6:20 p.m.
