Weeds and Grass



One of the first things that a passer-by notices about your property is the condition of the lawn and weeds or lack there of. This is why it the Borough enacted an ordinance to help protect the value of the community through curbing the overgrowth of weeds and grass through out one's property. The summary of Borough Ordinance 5-5001 states that weeds and grass shall be maintained below a height of 9 inches or the owner and/or the occupant may be subject to a cita-

tion. The average minimal cost of a citation is approximately \$170.00 including fines and court cost. The Borough understands that there are times when everyone falls behind on their yard maintenance form time to time but if the situation should become a chronic problem than a citation most probably would be issued.

Cleaning Up After Your Pet

This subject should go without mention, but if you are out walking your pet please take a second and clean-up after your animal. It is very neighborly to do so. If you have forgotten the appropriate clean-up material please return to the site and clean up as soon as possible. Please note that failure to clean-up after your pet would be a violation of Borough Ordinance 607 which says that if your walking your pet and they "go" on any property that's not yours you need to clean it up and properly dispose of it. Failure to do so could result a fine of up to \$600.00 and the cost of prosecution


100 YEAR ANNIVERSARY


A Christmas Eve Tradition Begins



Pennsylvania Dog Laws

<u>It is Unlawful</u>

- To keep or harbor any dog three months of age or older without a current PA dog license (due on or before January 1).
- To own a dog three (3) months of age or older without a current vaccination against rabies administered by a licensed veterinarian.
- To allow your dog to run at large. All dogs must be under control. Owners are responsible for all damages caused by their dog(s).
- To mistreat or abuse any animal. Report violations to your local humane organization or police.
- To place any poison or harmful substance in any place, on your own property or elsewhere, where it may be easily found and eaten by dogs.
- To abandon or attempt to abandon any dog. Fines for abandonment range from \$300 to \$1,000 plus court costs.
- To barter, trade sell or transfer any dog under seven weeks old.
- To operate a kennel that keeps, harbors, boards, shelters, sells, gives away or transfers a total of 26 or more dogs in any one calendar year without a current kennel license.
- For any person to interfere with an officer or employee of the Department in the enforcement of the Dog Law.
- For any person to knowingly make any false statement or to conceal any fact required to be disclosed under any of the provisions of the State Dog Law (Act 225).

Summary violations of the dog law cost up to a maximum of \$300 plus court costs.

Misdemeanor violations of the dog law cost up to \$2,000 plus court costs.



The applicant must be from a Borough which is a member of the Pennsylvania State Association of Boroughs (PSAB). The applicant must have been accepted for admission to an accredited College, University or School which offers a two (2) or a four (4) year degree/certificate program. The scholarship is for the first year (freshman) at the College, University or School.

The applicant must attach a picture which may be used for publicity purposes, and will not be returned.

Scholarship payments, in the amount of one thousand dollars (\$1,000), will be made directly to the College, University or School in which the applicant is enrolled. In the event that enrollment is not completed or the applicant withdraws before the end of the first year, the institution will be directed to return the money to the Foundation.




